The undersigned hereby applies to the City of Hartsville for a water/sewer supply, to be furnished through a meter, for which service the undersigned agrees to pay a monthly rate and minimum charge (whether the minimum volume of water is used or not) as may be established by Council of the City of Hartsville in accordance with its ordinances. It is understood and agreed that the applicant will comply with all rate schedules, rules, regulations and ordinances of the City of Hartsville in connection with this service; that the City reserves the right at any time without notice to interrupt water service for maintenance, repairs or extensions without any liability to the undersigned or owner of such premises for damages resulting there from; that the undersigned will not receive water from any part of the City water system without a valid permit from the City. **To connect service there is a non-refundable service fee due of \$30 (inside City limits) or \$40 (outside City limits).**

Water/charges billed will be based on water used as established by meter measurement. Cost of services will be billed monthly on or about the first of the month for a service period ending on or before the last day of the preceding month. Bills are sent by regular mail and the City is not responsible for insuring receipt by the customer. Payment is due no later than the 15th of the month. After the 15th a 10% penalty will be added to your bill. Service for accounts past due as of the 21st of the month are thereafter subject to interruption without further notice. Service may not be reestablished until the account is paid in full including all applicable penalties and costs. A tender of payment by check or draft which is returned for insufficient funds will result in service interruption without further notice.

By signing this application for water/sewer / residential and or commercial trash pick up service, the applicant agrees to pay all costs of collection of the applicant's unpaid bills. The City of Hartsville has the right pursuant to the South Carolina Setoff Debt Collection Act to collect any sum due and owed by the applicant through offset of the applicant's state income tax refund. If The City of Hartsville chooses to pursue debts owed by the applicant through Setoff Debt Collection Act, the applicant agrees to pay all fees and cost incurred through the setoff process, including fees charged by The Department of Revenue, the Municipal Association of South Carolina, and The City of Hartsville. If The City of Hartsville chooses to pursue debts in a manner other than setoff, the applicant agrees to pay the costs and fees associated with the selected manner as well. The undersigned agrees to notify The City of Hartsville with proper identification, when he/she desires to have the service terminated. A final reading of the meter will be taken within a twenty-four hour period and services will be discontinued. If your service is discontinued due to nonpayment, you will be subject to a reconnection fee of \$25.00 inside City limits/\$30.00 outside City limits.
